- 16/96.2 With regards to the Cheshire East Local Plan, having considered the issues raised through the examination process, the Inspector issued his views on further modifications needed to the Local Plan Strategy on 13 December 2016. As a result, the Council had proposed a series of Main Modifications to the Local Plan Strategy Proposed Changes (March
